

Through the generosity of our supporters, and the hard work of our members, we were able to put over 3,000 books into the schools.

Our New Member class this year was one of the largest we have ever had bringing in 33 new active members. This group of women are determined to serve as catalysts for change in our community, and showed that commitment by successfully completing two projects. They brought the LUNAfest film series back to Martin County at the beautiful historic Lyric Theater and raised over \$15,000.00 to benefit both the JLMC projects and the Breast Cancer Fund. They also established their Bag Buddies project, wherein they collected necessities and comfort items to be put into a duffle bag and given to children when they find themselves suddenly in the Foster Care system. Both projects were incredibly successful and we are fortunate to have these women as part of our organization.

As always, we could not promote voluntarism, develop the potential of women, or improve our communities without the support of our community partners and donors. I am thankful for the relationships we have fostered with each and every one of you and look forward to having the opportunity to continue to serve the community!

ABOUT THE JUNIOR LEAGUE OF MARTIN COUNTY

HISTORY

The Junior Service League (JSL) of Martin County, Inc. was founded in the spring of 1992 with the purpose of providing an ongoing program of education to train volunteers and encourage leadership in community service. Beth Conway, Kim DeMeulemeester, and Suzanne Karr were the driving force behind the establishment of the organization. These three women – along with 22 dedicated volunteers – became the charter members to address the needs of our community through volunteer service. They provided the foundation for the Junior League of Martin County (JLMC) as we know it today. The JSL became the Junior League of Martin County, Inc. in 2000, joining the Association of Junior Leagues International and continuing efforts to promote voluntarism, developing the potential of women and improving the community through the effective action and leadership of trained volunteers.

The Junior League of Martin County, Inc. is an organization of women committed to promoting voluntarism, developing the potential of women and improving the community through the effective action and leadership of trained volunteers. Its purpose is exclusively educational and charitable.

REACHING OUT STATEMENT

The JLMC reaches out to women of all races, religions, and national origins who demonstrate an interest in and commitment to voluntarism.

OUR MEMBERS

The JLMC membership is composed of a diverse group of more than 100 women who annually give over 500 uncompensated hours of service to projects and community agencies. Active members range in age from 21 to 85, come from various backgrounds, and serve on numerous boards and coalitions throughout the community.





ADVOCATES FOR CHANGE

Junior League of Martin County sits on the Junior Leagues of Florida State Public Affairs Committee. The Junior Leagues of Florida State Public Affairs Committee has monitored legislation and advocated for issues of importance to our members for almost 40 years. Together, we represent 21 Leagues and over 11,000 women from across the state. The following priority issues were identified for the 2016 legislative session:

IMPROVED EDUCATION

SB 96 High School Graduation Requirements (Sen. Hukill – Port Orange): Revising the requirements for the Next Generation Sunshine State Standards to include standards for financial literacy and one-half credit of instruction in personal financial literacy and money management. SB 198 Sales Tax Holiday (Sen. Hukill – Port Orange): Providing a sales tax holiday for the retail sale of certain clothing, school supplies, and personal computers and personal computer-related accessories. HB 241/SB 500 Children and Youth Cabinet (Rep. Harrell – St. Lucie/Sen. Montford – Tallahassee): The bill expands the total membership of the cabinet to 16 by adding a superintendent of schools who is appointed by the Governor. HB 887/ SB 468 Computer Coding Instruction (Rep. Adkins – Fernandina Beach/Sen. Ring – Margate): Requires high schools to offer computer coding courses and requires Florida College System & state universities to recognize the credits as foreign language credits.

AT-RISK YOUTH

HB 469/SB 818 Human Trafficking (Rep. Kerner – Palm Beach/Sen. Latvala – Pinellas): Providing that certain licensing boards must require specified licensees to complete a continuing education course on human trafficking as a condition of relicensure or recertification. HB 545/SB 784 Human Trafficking (Rep. Spano – Hillsborough/Sen. Flores – Miami): Providing that a licensed massage establishment may not receive a new or renewal license if specified persons connected with it are convicted of renting space to be used for lewdness, assignation, or prostitution. HB 4033/SB 874 Prostitution (Rep. Spano – Hillsborough/Sen. Hutson – Palm Coast): Revises definition of term "sexual abuse of a child" to delete references to prostitution offenses. HB 7055/SB 1396 Relating to Child Pornography (Rep. Spano – Hillsborough/Sen. Abruzzo – Palm Beach): The bill amends the definitions of the terms "sexual conduct" and "child pornography" to include morphed images of child pornography. As a result, persons who possess, promote, transmit, etc., morphed child pornography can be held criminally liable. SB 386/HB 147 Expunction of Records of Minors (Sen. Detert – Sarasota/Rep. Latvala – Pinellas): Provides for nonjudicial expunction of criminal history of offense after specified period for a minor who is not serious or habitual juvenile offender. HB 131/SB 308 Unattended Persons and Animals in Motor Vehicles (Rep. Young - Tampa/ Sen. Benacquisto – Ft. Myers): Provides immunity from civil liability for entering or damaging a motor vehicle to remove a vulnerable person or domestic animal under certain circumstances. The bill defines a "vulnerable person" as a minor or vulnerable adult. HB 293/SB 700 Public Records/Juvenile Criminal History Information (Rep. Pritchett – Miami Gardens/ Sen. Soto - Osceola): Specifies that certain confidential information relating to juvenile justice is exempt from public records requirements. HB 907/SB 884 Suicide Awareness and Prevention (Rep. Eagle – Cape Coral/Sen. Benacquisto – Ft. Myers): Requires DOE to incorporate training in youth suicide awareness & prevention into certain instructional personnel continuing education or inservice training.

HEALTH AND HUNGER

HB 153/SB 760 Healthy Food Financing Initiative (Rep. Santiago – Deltona/Sen. Bean – Nassau): Directing the Department of Agriculture and Consumer Services to establish a Healthy Food Financing Initiative program to provide specified financing to construct, rehabilitate, or expand independent grocery stores and supermarkets in underserved communities in low-income and moderate-income communities.

COMMUNITY SAFETY

SB 414 Use of a Tanning Facility by a Minor (Sen. Sobel – Broward): Citing this act as the "Preventing Youth Skin Cancer Act" and prohibiting a minor of any age from using a tanning device at a tanning facility unless a health care provider prescribes use of the device to treat a medical condition and the tanning facility has on file a specified statement signed by the minor's parent or guardian. HB 101/SB 380 Violation of an Injunction for Protection (Rep. Rodriguez – Miami/Sen. Abruzzo – Palm Beach): Providing enhanced criminal penalties for a third or subsequent violation of an injunction for protection.

Each year the new member class is charged with developing a project of their own which they develop and implement. This year these incredible women tackled two projects. First, they voted to bring LUNAfest back to Stuart, Florida. LUNAfest is a film series by, for and about women which benefits the Junior League of Martin County and the Breast Cancer Fund. The challenge they faced was they literally had no budget to make this happen. These incredibly resourceful women found two presenting sponsors, Drs. Craig and Edward Wengler and Martin Health Systems, who made it not only possible to bring the films but to also secure the beautiful historic Lyric Theatre as the venue. The event, which was planned in just three short months, raised \$15,000.00 to go back to the community. Based on the success of the event the League voted to continue LUNAfest for the upcoming year.

Second, the women developed a community wide program entitled Bag Buddies. They researched and selected multiple donation locations throughout the community wherein they collected duffle bags, necessities and comfort items for children who find themselves in protective custody either in local shelters or local foster homes. Through the program over 150 duffle bags were collected and distributed to area children.

The Junior League of Martin County is very fortunate to have these incredible women joining us in our mission and we are honored that they have all chosen to continue their membership with us.

Promoting Voluntarism, Developing the Potential of Women and Improving the community – the three tenets of the Junior League Mission which are fulfilled largely through out projects within the community. 2015-2016 brought exciting new projects to the League, while reinforcing past relationships and programs.

We started the year participating in the International Coastal Clean-up through Keep Martin Beautiful. Members provided over 40 volunteer hours working to clean Pendarvis Park in Palm City. This Annual Event affords members the opportunity to volunteer side by side with their families in this incredibly successful event.

Books for Kids was a new initiative started this year, a program to provide books to first year teachers in the Martin County Schools to stock their classroom libraries. This year long initiative brought classroom libraries to first year teachers throughout the Martin County School system.

In February, we returned to the Hibiscus Children's Center for our annual Valentine's Day themed party with the children. JLMC partnered with local vendors to bring a day of activities to the children including a bounce house, bird house building, cotton candy, arts and crafts and a little pampering. The children were also provided lunch and a healthy snack to end their day of fun and love.

Other collaborations included painting several classrooms at PACE in Fort Pierce; partnering with Devereux Community Based Care to host a breakfast bringing awareness of the state of the current foster care system; and providing volunteers to support the annual Zweben Bike Drive to benefit White Doves' holiday shopping event for local families in need. Junior League members provided hundreds of community service hours this year through all of our varied programs throughout the year.

BOOKS FOR KIDS

The Junior League of Martin County provided a total of 3647 books to new elementary school and ESE teachers throughout Martin County. The members hosted two book drives at Barnes & Noble to raise money and awareness and members provided attending children with a fun craft making Dr. Seuss themed masks. Members hosted four dedications (one at each school) with the Principals, Teachers and Literacy Coaches in attendance. Along with transporting, labeling, organizing and distributing the books, the members provided a total of 104+ hours on this project. Over \$5,000 in sponsorships and grants were allocated to this project. Due to the success of this program, the membership voted to continue this project into the 2016-2017 year.

RUDOLPH'S REINDEER DASH


